- \* Mandatory Advising 2 (60-70 units) Hold

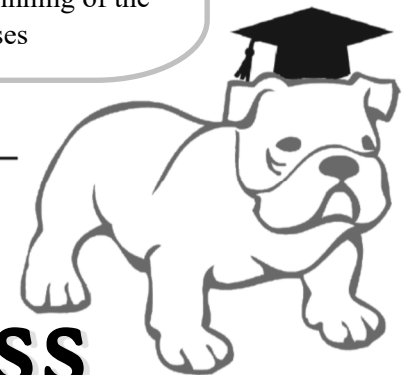
